1. Notice was issued to respondent No.3 on 02.08.2021. As per office report, respondent No.3 is served. However, no representation is made on his behalf.
2. Learned counsel for the petitioner submits that by this writ petition, petitioner has sought relief for a direction to respondent No.1 to consider and decide his application/representation /complaint filed against respondent No.3. He submits that as respondent No.3 is not present even after service of notice, this writ petition may be disposed of directing respondent No.1 to



take decision on the complaint made by the petitioner on 25.10.2020 which was forwarded through registered post on the same date i.e. 25.10.2020.

3. Learned counsel for the State submits that he is having no objection to the limited prayer made by learned counsel for the petitioner.
4. Heard learned counsel for the parties and also perused the documents annexed along with writ petition.
5. Annexure P1 is the copy of complaint/application/representation submitted by the petitioner on 25.10.2020 for taking action against respondent No.3. Perusal of Page No.20 of the writ petition which is part of Annexure P-2 would show that on 23.11.2020 some proceeding was initiated and inquiry report was also called for.
6. Learned counsel for the petitioner submits that till date proceeding based on his complaint/application is not concluded.
7. In view of the aforementioned facts of the case, submission of learned counsel for the parties, this writ petition at this stage is disposed of directing respondents No. 1 & 2 to conclude proceeding started on 23.11.2020 at the earliest, preferably within a period of 6 months from the date of receipt of order passed by this Court.
